#### 7. COUNCIL COMMUNICATIONS:

Council Member Acosta announced 4C4P meeting is tomorrow. She spoke at the Republican Women's luncheon on concerns regarding Prop.64 and importance on Measure J being passed for tax revenue.

Council Member LeBarre stated he attended the APTA conference, attended a Bicycles and Pedestrian Facilities Committee meeting for TAMC he was able to get a seat on the committee for the Master Plan for a bicycle path from King City to the Pinnacles, MST got grants for new buses and the new bus maintenance facility going into King City. He had a conversation with a gentleman that is the US

correspondent for the Railway Gazette and we may be able to get an article in about our Multi-mogul stop. No on Z meeting in San Ardo tomorrow he will be attending. Water meeting also tomorrow, MST meeting on Monday.

Council Member Hendrickson nothing to report.

Mayor Pro Tem Jernigan attended 100<sup>th</sup> anniversary of the National Parks Service. Attended the Art Jam at Sol Treasures. Saw the new Website up September 1<sup>st</sup>. Attended Code Enforcement meeting. A citizen asked her about clearing the Salinas river channel and San Lorenzo creek before we have a flood. Not able to attend the AMBAG meeting tomorrow she asked if the alternate could attend. Thursday and Friday is the Pinnacles Gateway two-day workshop. Dedication of Bacon-Ranch trail out at the Pinnacles. She is also hoping to attend El Grito. She is working with the Political Science class at Hartnell college for a Candidates forum on September 22 at 6:00p.m.

Mayor Cullen stated that the City Manager, Chief of Police and himself are meeting with Senator Cannella. He invited one of the Council and Council member LaBarre is going to attend at 11. He attended the Salinas Valley Fair board meeting he passed out their strategic plan to the council. On Saturday King City in Bloom is having a clean-up day meeting at Starbucks at 8. He asked the alternate (Council member Acosta) if she could attend the Salinas Valley Solid Waste Authority meeting on October 20<sup>th</sup>. He also had a letter on adopting a tobacco retail license ordinance. Council would like the City Manager research this.

#### **8. CITY STAFF REPORTS AND COMMENTS:**

City Manager Adams stated that City is having a Youth Violence Task Force meeting on September 21 at 6:00p.m at the Recreation Center. The first workshop on Street Scape Plan was last night. New website launched September 1, 2016.

City Manager Adams introduced Claudio Valenzuela, REO, Registrar of Voters Monterey County Elections he is explaining the elections polling places change to the High School, showing the new map and the change that two districts (2 and 5) will be "vote by mail" precincts as they have less than 250 registered voters as more than half the voters are vote by mail already. He further explained that voters in these districts can take their information and vote at one of the precincts if they feel more comfortable. They also can drop them in the drop box at City Hall and the precincts if they don't want to mail them. They are going to have meetings for information. They would like to get it out by radio He also supplied the Deputy City Clerk with the wording that is going go in the voter pamphlet.

Mayor and Council Member LeBarre are concerned about the cost and also people being used to voting how they are used too.

Up to 15 days before the election people can register to vote.

Mayor Pro Tem Jernigan spoke on Item F stating that she appreciated the design of the street light poles. This is going to involve some refinancing of the OpTerra solar project and she wanted to bring it to the council's attention. She is concerned that more than \$80,000 dollars has been paid in financing but no savings have happened yet because the project is not completed. She reminded the council that "OpTerra promises to manage the systems to produce a specified amount each year or the City will receive a check for the difference."

Mayor Pro Tem Jernigan moved to approve Item F. Seconded by LeBarre. Motion carried 5 (AYES)-0 (NO).

Council Member Acosta spoke on Item G she feels that the Council should be included in the list for Conflict of Interest. City Manager explained that City Council is already doing the Conflict of Interest. He stated that we could do the League of California Cities policy for Conflict of Interest. Council Member Acosta would like that.

Mayor Pro Tem Jernigan moved to approve Item G. Seconded by Hendrickson. Motion carried 5(AYES)-0 (NO).

Mayor Cullen spoke to Item K stating that the Fair board would like to have a representative on the Youth Task Force. City Manager is in favor of this.

Council member LeBarre made a motion to approve Item K with the change to include a representative from the Salinas Valley Fair board. Seconded by Hendrickson Motion carried 5 (AYES)-0 (NO).

# Mayor Cullen opened the public hearing

Jo Koester, thought that we were just growing the marijuana and shipping it out and now we are processing.

Mayor Cullen closed the public hearing seeing no one else come forward.

Council member Acosta asked for clarification on the Planning Commission and 600Ft. She also wanted to

know about the State and manufacturing. She thanked staff for all the hard work. She has no problem with the cultivation. She asked the City Attorney if they could separate it out with cultivation and manufacturing. City Attorney stated that he would suggest altering it and bringing it back for another first reading. She would like the 600Ft. on manufacturing.

Mayor Cullen explained that putting limits on 600ft it could backfire later for the City as far as growing. He would defer to the state.

Mayor Pro Tem Jernigan feels this is too complex. She feels that staff has worked hard to make sense of this and she is going with staff on this.

City Manager Adams stated that if Council would like to remove the 600ft. restriction, that at the staff level when CUP applications come in staff could do a check of the 600ft. and inform the applicant that if they go forward with their permit that they are taking a risk as there are state requirements pending.

Assistant Attorney Hale explained what legal non-conforming use was.

Mayor Cullen, Council member Hendrickson and Council member LeBarre would take the wording of the 600ft out at this time. Mayor Pro Tem Jernigan would like to leave the wording in.

Mayor Cullen ask for a motion to introduce the Ordinances by title only with the change of removing Section 17.03.090 (D) (600ft.) and schedule the second reading and adoption for the next regular City Council meeting.

Gina Barrios, San Ardo School District, the school needs the oil fields to stay open. Chevron helped the

school stay open. Chevron supports lots of activities in King City.

Brandi Garza, Chamber of Commerce, encourages a no vote on Measure Z

Mary Shaw Coreon, proponent of Measure Z is a volunteer and concerned about the water. She is concerned about the water contaminating ag fields.

Margaret Benetti, stated that the money does not come from Doyle (Chevron) to help schools it comes from the government. She referenced that Oklahoma had earthquakes from fracking.

A Citizen of Greenfield, is concerned about the water and ag chemicals in the water from the fracking process.

Council is in consensus with being in opposition of Measure Z.

Page 16 take out word initially & Should those contingencies not materialize within a 10-year period from the execution of the MOU, City may elect to accept the Offer of Dedication if other options for the use of those right-of-way are identified.
