# **MINUTES**

#### 1. CALL TO ORDER

The meeting was called to order by Acting Chairperson LeBarre at 6:00 p.m.

#### 5. SELECTION OF CHAIR AND VICE CHAIR

A. Oath of Office for new member Bill Casey

Airport Manager/City Manager Adams swore in Mr. Casey.

B. Selection of a Chairperson and Vice Chairperson by a vote of the committee for a period of one year. Per Municipal Code §2.30.340 Airport Advisory Committee, at the first meeting of each calendar year, the committee shall elect a chairperson and a vice chairperson within its membership, who shall serve until the first meeting of the following year. A chairperson and vice chairperson may be elected for successive terms, without restriction as to number.

Committee Member Casey nominated Committee Member Francis Chair, Committee Member Francis accepted Seconded by Committee Member Francis and he was approved unanimously.

Committee Member Casey nominated Committee Member LeBarre Vice Chair, Committee Member LeBarre accepted Seconded by Committee Member Francis and he was approved unanimously.

#### 6. PRESENTATION

A. Board member of the Association of California Airports - Rayvon Williams

Mr. Hurtado introduced Mr. Williams.

Mr. Williams explained the Association of California Airports and he invited Octavio to go the conference in Lake Tahoe.

Mr. Williams started in 2011 as Airport Manager, he gave a back ground on the history of Watsonville airport. There is a strong navy history there. He suggested that King City check in with Cal-trans for \$10,000 grant for maintenance. He represents King City. He covers Watsonville, Hollister, Frasier Lake, Marina, Monterey, Salinas, Paso Robles, San Luis Obispo, King City.

He would encourage King City to know all the people in FAA.

He spoke to how to make revenue. He spoke to the STEM program working at the Airport with the youth. He spoke to the open house that they had. They had 8,000 people. They do it on 4th of

July bringing in all the emergency services and fireworks at the end.

He feels that King City asset is the tenants, reach out to them to see what they are interested in and use the STEM program. Call ALOPA and ask them to reach out to the tenants. Jeff in Marina would be a good go to person. We have a good aerobatic pilot here in King City already with Sean Tucker that should be used. California Land Use handbook.

Mr. Hurtado presented this item. Joe Bradshaw gave a review of the Airfield Electrical Improvement Design. 3 alternate bids were discussed. (GET FROM BID PACKET)

Mr. Hurtado further explained that the PAPI on runway 11 could be added later so the design can be done now. Design will also be done for foundation for signs and a building that when we have money later a new building could be build. The plans will be on the shelf for a later project. The reels will be angled differently for the existing PAPI as they were set a zero. The lamps have burnt out on the PAPI from them being on all the time so they are being looked into to see if timers could be use.

Advisory Member LeBarre made a motion to approve staff's recommendations and it was seconded by Chair Francis. Approved 3-0.
