### 5. REGULAR BUSINESS

A. Consideration: Strategic Plan Visioning Process Recommendation: 1) receive a presentation by staff on the strategic planning process, SWOT (strengths, weaknesses, opportunities and threats) Analysis, and long-range projected needs and issues; and 2) provide staff direction on Strategic Plan Vision Statements.

City Manager Adams introduced this item with a PowerPoint presentation.

The following summary of the draft direction provided by the City Council relative to the 20-year vision for the City.

#### **General Tone**

As part of the general conversation relative to the 20-year potentials for King City, the following comments provided a general framework for the development of the more specific vision categories following.

- Growth that is defined by the population being served by 1 high school
- The principle of moderation to be applied consistently, with the thought of a sustainable community
- Multi-level housing concerns to be addressed, including:
  - o Potential of rent control related conversations
  - o Allowing density
  - o Encompassing new technologies: cars, automated transportation, etc.
  - o Generation of options for elders in need
- Family units form the basis for the community
- Maintaining a "village" feel, perhaps zero stop lights, very European
- Support our agricultural base; hospital
- Using the potential of the cannabis industry to leverage other light industries

#### **Mission Statement**

The Mission Statement, *Meeting the needs of our entire community through caring, professional and response services*, informs the entire visioning process. It is carried out through the following Vision Categories.
