# **10. PUBLIC HEARINGS:**

A. Consideration: An Ordinance of the City Council of the City of King Amending Chapter 17.03, Sections 020, 040, 060, 070, 210, 230, 260, and 270, and Chapter 17.30, Section 020 and Chapter 17.31, Section 020, of Title 17 of the King City Municipal Code Chapter Pertaining to commercial Cannabis Activity, Including Manufacturing Permits, Cannabis Activity Limitations, and Cannabis Deliveries Within the City of King

Mayor LeBarre read the title into the record. City Manager Adams introduced this item.

Council member Cullen wanted to know what Planning Commission stated at their meeting. Principal Planner Scott Bruce informed the Council of what the Planning Commission stated. The Planning Commission wanted the cap at 50%.

Council member Cullen also wanted to know about mixed use and how it would be counted. City Manager Adams explained that it would be calculated individually.

Council member Acosta wanted an explanation on deliveries in town. City Attorney Santos explained that the state has put regulations in place that we can not over ride. There are some mechanisms in place like checking ID's upon delivery and the recipient needs to be 21 years or older. There is a tracking system in place that tracks it from the dispensary to where it is delivered.

Mayor LeBarre clarified that there is a regulation against bad actors from the state as there is a way to complain to the state to get them.

Mayor LeBarre opened the public hearing, seeing no one come forward, Mayor LeBarre closed the public hearing.
